This Amendment No. 2 to the Schedule 13G (this "Amendment") is being filed on behalf of Fir Tree, Inc., a New York corporation ("Fir Tree"), relating to Common Stock, \$0.001 par value (the "Common Stock"), issued by iStar Financial Inc., a Maryland corporation (the "Issuer"), purchased by certain private investment funds for which Fir Tree serves as the investment manager (the "Funds").

(a) Fir Tree may be deemed to beneficially own the 1,312,300 shares of Common Stock held by the Funds as a result of being the investment manager of the Funds.

- (b) Fir Tree beneficially owns 1,312,300 shares of Common Stock, which represents approximately 1.6% of the Common Stock outstanding. This percentage is determined by dividing the number of shares of Common Stock beneficially held by Fir Tree, by 83,647,510, the number of shares of Common Stock issued and outstanding as of November 2, 2012, as reported in the Form 10-Q filed by the Issuer with the Securities and Exchange commission on November 9, 2012.
- (c) Fir Tree has been granted investment discretion over the shares of Common Stock held by the Funds, and thus, has the shared power to direct the vote and disposition of 1,312,300 shares of Common Stock.
